National Police Service Medal – Australia

On 2 March 2011, the Australian Government announced the creation of the National Police Service Medal – a national award recognising the special contribution that sworn police officers make in protecting the community and the importance of ethical decision making and diligent work in this special job. Sworn police officers in any Australian jurisdiction with at least fifteen years of ethical and diligent police service on or after 30 October 2008 will be eligible for the award.
